Motion to adjust the Capital Improvement Fee

The Capital Improvement Fee is charged when a property in LHC is sold. The fee for an improved lot is the amount of the previous year dues. The fee for an unimproved lot is half the amount of the previous year dues. Transfers of property from parent to child are exempt from the Capital Improvement Fee. Transfers of property to a financial institution in the event of a foreclosure are exempt from the Capital Improvement Fee. Transfers of property to qualified real estate investors of unimproved property are exempt for the first two years the property is owned. A qualified real estate investor is a person or entity which has a portfolio of at least 2 other properties, located inside or outside of Lake Hauto Club.
