New Business:

- Revision to Lake Hauto Club Rule & Regulations, Section T Collection of Dues Completely replace existing Section T wording with:
 - 1. Annual dues shall be payable by the first day in March. The dues may either be postmarked or in the office by said date. Members paying with checks that are returned incur the same penalty as members not paying on time.
 - 2. Dues paid between March 2 and April 1 shall incur a 5% penalty.

- 3. Dues paid after the first day in April shall incur an additional 10% penalty. That is, a total penalty of 15% of the original dues amount.
- 4, Dues paid after the start of the following calendar year will incur an interest charge equal in amount to the percentage increase of dues from the year in which the dues were originally payable to the current year.
- 5. Dues notices shall be mailed by the seventh day of December or as soon as possible after that date, and no later than December 31.
