#### 2. Amend Rule M2:

A motion is made to approve the following change to the rule book:

Replace the current wording of rule M2 with:

M2: Pets are not permitted on the beach (sand area) or in the swimming area of Eastwood, Oakwood, and Crescent Beaches. Pets are not permitted on the baseball field, children's playground, basketball court, and tennis court at Crescent Recreation area. Pets are not permitted on the basketball court and children's playground at Eastwood Recreation area. Pets are not permitted to be on the children's playground, basketball court, and bocce court at Oakwood Recreation area. Pets are permitted to cross the sand area on Oakwood Beach in a minimal manner to go to a member's boat docked at Oakwood Dock B.

3. Send a Special Assessment out for a Member Referendum:

The Board, requiring approximately \$340,000 to re-pave Great Oaks Drive from Lake Drive to Lake Drive, is asking for the Members to approve a \$300 per lot Special Assessment. This assessment will bring in \$204,000. The difference will be made up by allocating funds from our Reserve Account and unused 2023 paving contingencies funds. A motion is made to approve sending out for a Member Referendum the approval of a \$300 Special Assessment.
