HE STATED 2 BUDGETS WERE POSTED WITH AND WITHOUT THE ASSESSMENT THE ROADS ARE DETERIORATING AND THEY ARE PRIORITY NOW WITH NOT HAVING THE EXTRA FUNDS SINCE ASSESSMENT WAS VOTED DOWN BY MEMBERS.

RAY DOYLE STATED IT IS VERY SAD THAT THE PEOPLE IN HERE VOTED TO NOT RAISE THE DUES/ASSESSMENT, HE STATED IT IS AN EMBARRASSMENT THAT THEY DO NOT WANT TO KEEP IT UP FOR THE CLUB.
