- Motion made by R. Brightman, seconded by N. Seifert, to approve the December members meeting minutes. All in favor, motion carried.

### 2. Approval of Bills to Be Paid

- Motion made by R. Brightman, seconded by L. Mosser to approve bills to be paid. All in favor, motion carried.

#### 3. Approval of the Treasurers Report

- Motion made by H. Tokosh, seconded by M. Infante to approve the Treasurers Report. All in favor, motion carried.

### 4. Motions and Discussion

- a) Motion made by H. Tokosh, seconded by L. Mosser, to order the disconnect of the cable television in the Community Center. All in favor, motion carried.
- b) Motion made by R. Brightman, seconded by M. Infante, to direct Stan Burke to prepare a response to the east entrance objections filed by the water authority with a maximum cost of \$800.00. All in favor, motion carried.
- c) Motion made by R. Brightman, seconded by L. Mosser, to approve the 2006 budget. All in favor, motion carried.
- d) N. Seifert reported that minor work on recreation equipment will be done over the winter including adding preservative to the adult swings and lifeguard chairs.
- e) Motion made by J. Totani, seconded by M. Infante, to cancel the election post office box. All in favor, motion carried.
- f) Motion made by R. Brightman, seconded by H. Tokosh, to set the 2006 employee vacations as follows: New Years Day, Good Friday, Memorial Day, Fourth of July, Labor Day, Columbus Day, Thanksgiving Day, Christmas Day. Employees will have the choice of taking the day after Thanksgiving off in lieu of Columbus Day. If a holiday falls on a Saturday, the day off will be Friday. If the holiday falls on a Sunday, the day off will be Monday. All in favor except N. Seifert against, motion carried 6 1.
- g) Discussion held on Mr. George Stewart's response to his notice of violations. Motion made by R. Brightman, seconded by H. Tokosh, to cite Mr. Stewart a second time, at \$100 per violation. All in favor, motion carried.
- h) Discussion held on Jayne Hartenstine's letter requesting to use the Crescent Beach ball field for a wedding picnic for her niece. An engineer will be consulted to determine the best course of action.
- j) K. Snyder reiterated that no fences are permitted at Lake Hauto except for short decorative corner pieces.
