### Minutes of Lake Hauto Club Board of Directors Meeting 17 December 2010

### 1. Opening remarks

Boats can be put at Crescent, Oakwood and the greenbelt by Meadow Run after 1 April 2010. A registration sticker must be on the boat and the dock fee must be paid. The contract to complete the mapping project has been signed. The Club finished the year with a deficit of \$24,000. It is intended that the money will be paid back by 1 February 2011. The wires for the cameras by the gate were checked by the phone company. The volleyball court will not be moved. It would have cost seven to eight thousand dollars. We have a 25 foot easement. The club has a highway occupancy permit to remove trees on the south side of the lake. We were paid half of the money due us and will receive the balance when the trees are cut.

Motion 2 Motion by J. Mikovich to appoint Bill Schmidt treasurer. Seconded by C. Gangaware. All in favor. Carried.

Motion 3 Motion by G. Makovec to approve the budget for 2011. Second by B. Schmidt. All in favor. Carried.

Motion 4 Motion by Bill Schmidt to have contractors pay a fee of \$100 per year or \$10 per job to do work at Lake Hauto Seconded by G. Makovec. Roll call. Jamie Kane-No, G. Makovec-Yes, C. Gangaware-No, H. Tokosh-No, B. Schmidt-Yes, J. Mikovich-No. Motion fails 4-3.

Motion 5 The following motion was made by G. Makovec and seconded by C. Gangaware. Roll call. G. Makovec –Yes, J. Kane-Yes, C. Gangaware-Yes, B. Schmidt-Yes, H. Tokosh-No, J. Mikovich-No. Motion passed 4-2.

All Lake Hauto Club members (the "member") shall maintain his/her property(ies) in compliance with the borough/township ordinances in which the property(ies) is located. All plant life on the side of the property(ies) abutting any road owned by Lake Hauto Club shall be trimmed at a minimum of one (1) time per calendar year. A swale or its equivalent shall be installed (and subsequently maintained) along the side of the property(ies) abutting the road and the water drained through or under the property(ies) so that the water runoff is properly disposed (i.e. the water may not be directed to flow onto the roads or another property owner's lot).

Violations of the above will result in a written notice detailing the violation. The member shall have thirty (30) days to correct the identified problem and bring the property(ies) into compliance with the cited rule or submit a written appeal to the violation notice detailing the reason(s) why he/she should be exempt from the rule or why he/she is objecting to the violation notice and a hearing shall be scheduled. If the violation is not corrected and/or a timely appeal is not submitted, then a Lake Hauto maintenance

crew shall perform the necessary correction at the expense of the property owner (a fee of \$10.00 per square foot of corrected area will be assessed and the cost of any materials used to complete the work). The property owner will be billed upon completion of the work and payment will be due within 30 days.

#### Motion 6

A motion was made by B. Schmidt and seconded by H. Tokosh to give each employee a \$100 bonus. All in favor. Carried.
