- 2. A motion was made by G. Makovec, seconded by J. Kane, to change #17 under Watercraft to read: No diving and /or swimming will be permitted from watercraft at any time except from the breast of the dam out 75 feet. There will be markers for the area. All in favor, motion carried.
- 3. A motion was made by J. Kane, Seconded by P. Whitely, to have an assessment for roads of \$100.00. The date of the mailing and to de determined. Roll call vote: Yes: J. Kane, P. Whitley, B. Schmitt, G. Demetriades, C. Cochran, and C. Gangaware. Abstained: G. Makovec. Motion carried.
- 4. A motion was made by J. Kane, Seconded by G. Makovec, to make a new rule that only proper licensed and inspected (Where it applies) motor vehicles can be parked on CLUB MEMBERS properties. Roll call vote taken and all in favor, motion carried.
- 5. J. Kane mentioned that they recently fixed the baseball field at Crescent Beach. Thanks to G. Makovec for use of his machine.
- 6. P. Whitley mentioned that the Community Center needs to be put back into its original set up after it is used by not only the members but by the club itself. It is inspected after each use.
