- 3. Althea asked about the registering of boats in 2014. K. Snyder reported that the names on the deed for the property can register the equipment. A copy of the deed has to be in the office.
- 4. Greg Slivka wanted to make the board aware that the gates are remaining up for a long period of time. K. Snyder reported that the gates are timed to stay up 3 seconds after the vehicle passes. The visitor's lane was 9 seconds and will be changed to 3 seconds.
- 5. Discussion held regarding how far away the Fobs work. Right now they are inconsistent in the distance that they work. Hope to make adjustments to correct that. The gates are working with just minor things to be adjusted.
