#### **LEGAL**: K. Snyder

1. Court hearing with Missy Griffiths was held on October 9, 2014. We lost the law suit. Ms. Griffiths installed a drainage pipe on our property and she wants us to pay for it. Amounts to about \$3900.00. We will now sit down with her attorney, her engineer and herself to work out an agreement. We will also appeal the decision. This was non-binding arbitration.

#### **DISCUSSION FROM THE FLOOR:**

# **NEW BUSINESS**

- 1. A motion was made by B. Davidovich, seconded by C. Gangaware, to approved 2015 dues for \$560.00 per lot. This was the increase by the CPI. All in favor, motion carried.
- 2. A motion was made by D. DeMelfi, seconded by S. Murphy, to keep the fees for Docks and RVs the same rate. All in favor, motion carried.
- 3. A motion was made by D. DeMelfi, seconded by J. Murphy, to change the fees for the boats. Boats with 10 horsepower and under will remain at \$12.00 per boat. Boats with horsepower above 10 horsepower will be \$36.00 per boat. All in favor, motion carried.
- 4. A motion was made by S. Murphy, seconded by C. Fulton, to keep all building fees, Road Opening fees, Initiation fees, Resale Certificates and Water License Agreements, and Community Center rentals fees will all remain the same as in 2014. All in favor, motion carried.
- 5. A motion was made by C. Fulton, seconded by J. Murphy, to change the Tree Permit application. The permit will be \$25.00 for the application. For dead or encroaching trees there will not be an additional fee. If the tree is being taken down for "convenience", there will be a required \$50.00 deposit per tree. Once the tree is replaced with another tree of at least 2 inch caliper, the deposit will be refunded. All in favor, motion carried.
- 6. A motion was made by D. DeMelfi, seconded by S. Murphy, to approve Peter Radocha & Sons for back up plowing in the case of emergency. All in favor, motion carried.
- 7. A motion was made by C. Fulton, seconded by C. Gangaware, to approve Attorney Thomas Nanovic from Nanovic Law Offices as the club's attorney. All in favor, motion carried.
- 8. A motion was made by S. Murphy, seconded by J. Murphy, to approve Ron Tirpak from Carbon Engineering Inc. as our surveyor. All in favor, motion carried.
- 9. A motion was made by S. Murphy, seconded by D. DeMelfi, to accept the notarized agreement with Charlie Price and make it a part of the minutes. All in favor, motion carried.

#### **CLUB MEMBER DISCUSSION**

- 1. Althea Higgins questioned what the agreement with Charlie Price was. K. Snyder summarized it that he will have to notify the office 2 days prior to his having equipment on his property and then have it removed 24 hours later.
- 2. There was discussion about the way that the man was being paid for work on the dam. It should be just \$30.00/hour and not broken down between hourly wage and taxes. There is \$10,000.00 in the budget for dam repair.
- 3. G. Gangaware informed the board that he inspected the electrical wiring in the Community Center and it is in good shape. Discussion held.

A motion was made by B. Davidovich, seconded by S. Murphy, to adjourn the meeting. All in favor. The meeting was adjourned at 7:45 P.M.
