DISCUSSION FROM THE FLOOR:

- 1. Althea Higgins asked if we are still going to sale Tippets Road. We are and call if you see it getting bad.
- 2. Marianne Jones asked about the PPL project at the west end of the lake. Chester Gangaware explained that PPL is installing a loop so that if the power goes out, they can loop around the problem and get power from the other end. This can then narrow down and located the outage area. They probably will be replacing the existing poles in Birch pools area. The utility company can do what they want to accomplish the results of their project. Discussion held.
- 3. D. DeMelfi has had requests to reline Lake Drive. It will be scheduled for March.
- 4. A Higgins asked about the large number of trees that came down out a home on Dogwood Lane. It was explained that the committee did discuss with the member and that they compromised but many were dead or too close to the home.

NEW BUSINESS

1. K. Snyder read a motion to change the boat rule to: Pontoon boats will be 20 feet or less and are limited to an engine of 150 horsepower or less. Pontoon boats are measured by deck size. The old rule is: Pontoon boats will be 20 feet or less and have motor of four cylinders or less. Pontoon boats are measured by deck size. B. Davidovich made the motion. There was no second to the motion, therefore the motion died due to lack of a second.

2. B. Davidovich made a motion, seconded by C. Gangaware, to remove the requirement that all contractors must first register with the office, provide a copy of their insurance and pay a fee. (This was motioned in 2011) This will become effective immediately. All contractors working for the club must provide a copy of their insurance. All in favor, motion carried.

CLUB MEMBER DISCUSSION

- 1. There was a discussion about pontoon, their size and engines.
- 2. There was a discussion regarding Piacenti's replacing their current wooden dock with an aluminum docks. Their dock goes out 40 feet. Discussion held.
- 3. Discussion about lily pads and chemical lawn care in our community. The chemicals all help to feed the water vegetation growth.
