FINANCE: (Ken Snyder)

- 1. K. Snyder reported that 93% of the membership has paid by now and things are going great.
- 2. The board decided to secure a loan for \$500,000.00 for 4% interest paid once a year. We put out the bid for the loan to several banks. Securing the loan was based on the assessment for 7 years at \$100.00 per lot.

2. We are looking into putting up a tower to shoot a beam to all the beaches. We are hoping that this will reduce the cost.

DISCUSSION FROM THE FLOOR:

- 1. Lenny Ciszek asked if the board has created a policy for planting trees at the beaches. We need a fixed cost to plant a tree. S. Daderko will look into the type of trees to plant. Greg Slivka said that Marcia Evans was looking into prices for maples and oaks. One needs to be planted in the spring and the other is for the fall.
- 2. Lenny Ciszek asked if they are spraying for gypsy moths this year. G. Demetriades reported no and that it is not recommended by the county.
- 3. Lenny asked about the towers and where they would be placed. Discussion held.
- 4. Steve Lukach had a suggestion regarding planting trees. He said that the people should just get permission from the club as to where they can plant the tree and then get it on their own and care for it until it gets established.
- 5. Bryan Smith thanked the board for all that they do. He explained that when he wrote an email to them, that he did not realize that the ATV rule has been in existence since 2004. He asked if we could revisit the times of operation in the rule. Discussion held. G. Demetriades asked the members present what course of action they would like the board to take. More discussion held.
- 6. A member said that as a safety issue, that there are branches that need to be trimmed along the roads. This would be to increase the line of sight. G. Demetriades said that they are looking into hiring an outside firm to trim the trees along the roads.
- 7. Charlie Sincavage recommended sending out a follow-up email that we caught the gate violators
- 8. Charlie Sincavage asked where the extra money came from for the roads. It was decided that the Road Assessment account should just be called Roads since additional monies where put into the account from other accounts and not just the assessments.
- 9. Charlie Sincavage asked why Hickory Terrace was ignored when plowing. An oil delivery truck could

not get in to make a delivery. B. Davidovich would check it and have maintenance there in the morning.

10. Greg Slivka asked about a stop sign that is missing at the intersection of Dogwood and great Oaks Drive.

G. Demetriades said that there are many intersections that do not have stop signs.
