In fact, some roads, such as many of the cul-de-sacs, would be blocked if someone were parked on the road surface. For this reason, we ask that you do not park on the street. If you or your guests must park on the street, please park with at least half the vehicle off the paved street surface ensuring that the roadway remains passable. In addition, do not park within 20 feet of a fire hydrant, nor 30 feet of an intersection. We need our roads to remain open to travel by larger and longer vehicles, such as fire trucks, ambulances, delivery vehicles, and people towing boat trailers.

Rules and Regulations Section BB (3)

Original:

3. In addition to the fine provided in Section AA (1) above, upon being found liable as provided in Section Z above, the Board of Directors may suspend the members membership rights for a term not to exceed one (1) year, or until the violation is corrected, whichever is longer.

Replacement:

3. In addition to the fine provided in Section BB (1) above, upon being found liable as provided in Section AA above, the Board of Directors may suspend the members recreation rights, including the right to register recreational vehicles, utilize the recreational facilities, rent community property, and vote in club elections, until the violation is corrected and all fines, fees, and Dues are paid.

Original:

6. The Board of Directors recognizes non-payment of dues and assessments as a serious infraction warranting special fines as penalty if the non-payment requires the filling of suit against the delinquent member. The fines shall be levied according to the following fine schedule and will be in addition to other penalties if suit is filed by the Club. Prior to filing suit, the Club will provide the delinquent member with notice by first class mail of his outstanding delinquent dues, assessments and penalties and will give the member a minimum of thirty (30) days to pay that amount before the below fines are assessed.

First Year Delinquent \$25.00 Fine

Second & Third Years Delinquent \$75.00 Fine

Fourth & Fifth Years Delinquent \$100.00 Fine

More than Five Years Delinquent at the discretion of the Board, not to exceed \$250.00/lot.

Replacement:

6. The Board of Directors recognizes non-payment of Dues and Assessments as a serious infraction warranting special fines as penalty if the non-payment requires the filling of suit against the delinquent member. The fines shall be levied according to the following fine schedule and will be in addition to other penalties if suit is filed by the Club. Prior to filing suit, the Club will provide the delinquent member with notice by first class mail of his outstanding delinquent dues, assessments and penalties and will give the member a minimum of thirty (30) days to pay that amount before the below fines are assessed.

First Year Delinquent \$25.00 Fine

Second & Third Years Delinquent \$75.00 Fine

Fourth & Fifth Years Delinquent \$100.00 Fine

More than Five Years Delinquent at the discretion of the Board, not to exceed \$250.00/lot.

Members with delinquent Dues and Assessments are considered not in "Good Standing" and are ineligible to vote in club elections, register recreational vehicles, utilize the recreational facilities, and rent community property.
